

**SITE ALLOCATIONS PLAN  
DEVELOPMENT PLAN DOCUMENT****Notice of Public Consultation  
on the Revised Preferred Options****Site Allocations Plan**

**Under the Town and Country Planning (Local Planning) (England)  
Regulations 2012 - Regulation 18**

The District Council is preparing a Site Allocations Plan Development Plan Document which is an additional plan that will sit alongside the adopted Core Strategy. Together, they will enable residents, businesses and communities to know where new development may occur in the future.

**The Plan includes a range of policies and proposals across the District relating to:**

- **Reserve Housing Sites**
- **Self-Build and Custom Housebuilding**
- **Built-up Area Boundaries**
- **Employment Enabling Sites**
- **A46 Safeguarding**
- **Specific Site Proposals**

Preparing the Plan involves a number of stages. Preferred Options is essentially the draft stage. The District Council published an initial version in October 2022 but in light of changing circumstances has decided to produce a Revised Preferred Options Plan for public consultation. A Proposed Submission version will then be produced for statutory consultation before it is submitted to the Government for independent examination.

**The consultation period on the Revised Preferred Options Site Allocations Plan runs from Thursday 16 June to 5.00pm on Friday 29 July 2022. The District Council is inviting comments on the Plan and its supporting evidence.**
